### 1/ What's changed?

- 31 Dec 2021 free trade with EU ends. Customs duties & taxes applicable on all imports entering EU
- 1 July 2021 EU VAT reforms introduced. VAT must be collected, declared and paid on all goods sold to customers within EU
- 1 July 2021 The Import One-Stop Shop (IOSS) goes live designed to simplify VAT compliance for distance sellers of low-value goods
- UK ecommerce businesses have stopped, reduced or avoided selling to EU





### 2/ What is IOSS?

- "The Import One-Stop Shop (IOSS) is the electronic portal businesses can use since 1 July 2021 to comply with their VAT e-commerce obligations on distance sales of imported goods"
- Optional scheme, designed to simplify the Collection, Declaration & Payment of VAT on low value goods not exceeding €150 (excluding VAT)
- Enables SINGLE VAT registration and SINGLE periodic VAT submission to ONE member state to fulfil VAT obligations across all 27 EU Member countries
- No import VAT charged when goods clear through customs (fast release)
- Used by Marketplaces and by retailers with their own website





### 3/ What is covered/not covered under IOSS?

The IOSS covers the distance sale of goods that are:

Dispatched/ transported from outside of the EU at the time they are sold Dispatched/transported in consignments with an \*INTRINSIC value **not exceeding EUR 150** (low value goods\*) even if the order contains more than one item

Not subject to excise duties (typically applied to alcohol or tobacco products)

\*The intrinsic value of the goods is the price of the goods themselves, when they are sold to the EU, excluding transport or/and insurance unless this is included in the price (rather than indicated separately on the invoice), and excluding any other charges/taxes.

### 4/ What makes IOSS good for business?



#### **SAVES TIME**



#### 95% reduction in red tape

Register for VAT in one Member country – not all 27

Single consolidated monthly VAT return – not multiple

IOSS Identification number makes Customs clearance faster, smoother less risk of parcel delays

#### SAVES MONEY



Cash Flow – VAT payments to EU Tax Authorities are monthly

Avoid paying courier fees for VAT clearance services

Pay just one tax authority in one currency

Lower handling costs by carriers

#### **GOOD CUSTOMER EXPERIENCE**



VAT cost transparency at the point of purchase

Confidence they are being charged VAT at the rate applicable for goods delivered to their destination

Ease of payment – VAT payment is made directly at the point of purchase

No nasty surprises – no unexpected VAT payment requested prior to receipt of goods

# **5/ VAT compliance under IOSS** what do you need to do?



- 1. Register for IOSS with the tax authorities
  - EU established sellers must register in their member state of establishment
  - Non-EU established sellers can choose any EU member state to register
  - Non-EU established sellers must have an EU established intermediary
- 2. IOSS VAT ID to be used for IOSS only, not other supplies
- 3. Calculate, display and collect VAT from customer at the point of online sale rates vary by EU member state, determined by customer location
- 4. Refund VAT to customer on returned goods
- 5. File monthly VAT declaration before the end of month M+1 (include adjustments for returns)
- 6. Keep records of all eligible IOSS distance sales of imported goods for 10 years

### 6/ Shipping under IOSS what do you need for a smooth customs clearance



#### Outbound

- 1. Goods must be shipped in consignments not exceeding EUR150
- \*Provide required data to carrier for Customs Import declaration and clearance:
  IOSS data for VAT clearance:
  - IOSS VAT Identification Number (or Marketplace IOSS Number)
  - VAT collected per item in EUR


#### Plus, data required for CUSTOMS clearance:

- EORI number
- Product HS code & Description
- Product Value, Weight, Country of origin

#### **Inbound Returns**

- 1. Provide required data to carrier for Customs **Export declaration** and clearance and tax relief:
  - EORI number, HS Code & Description, Value, Weight, Country of Origin
  - Outbound tracking number, Carrier, Returned Goods Relief (RGR) number and Customs
    Procedure Code (CPC)

\* Physical Commercial Invoice or, transmit data electronically direct to carrier via your shipping platform (Paperless trade – PLT)






